Invitation to submit a paper

Papers are expected to make an original and substantial contribution to the conference themes and topics. Speakers who are interested in presenting a paper should send an abstract for refereeing. Paper proposals will be selected by the conference scientific committee to cover different areas, methods, approaches and positions.

Abstracts should be maximum 300 words. Each entry should incorporate the following information:

Author's(s') full name(s), Title – Position – Institution – Address for correspondence—Theme of the paper (see conference themes), indicating a first and second choice – Title of the paper – Abstract of the paper.
