2009 is an important year for European water policy. By the end of the year the first River Basin Management Plans must be established, laying down specific measures to ensure that all EU waters reach good quality status by 2015.

The successful development and implementation of River Basin Management Plans is key to European water policy and offers the opportunity to take key decisions on our water management for the future. How should agriculture contribute to good water management? How can we modify watercourses in a sustainable way? How can we send the right price signals to faciliate sustainable water use? How can we manage European watercourses in the view of the impacts of climate change?

None of these questions are easy and therefore the Water Framework Directive gives interested parties and the public the right to be involved and consulted in order to ensure the best decisions are taken.

The European Commission would like to take the opportunity to invite decision makers and interested parties from across the EU to the 2nd European Water conference to discuss strategic water management issues and how you can become involved.

Public information and consultation

Article 14 of the Water Framework Directive requires Member States to actively involve interested parties in the consultations on draft River Basin Management Plans and to make these drafts available for comments in writing from the public during a 6 month period – starting at the latest 22.12.2008. 
